1. INTRODUCTION:

The Foreign Student Registry (FSR) is the Nodal Office for admission of foreign nationals at the University of Delhi in various Programmes of Study being taught in its various Colleges, Departments and Centres. To know more about the various academic programmes, please visit the University's website (www.du.ac.in).

All the information related to admission for foreign nationals is available at the FSR website (www.fsr.du.ac.in).

2. BASIC ELIGIBILITY FOR ADMISSION

Candidate who hold a non -Indian Passport



A Non-Resident Indian (NRI) whose qualifying examination is from an International Board or a Foreign University **is not eligible** for admissions under the Foreign Student Registry if he or she has an Indian Passport.



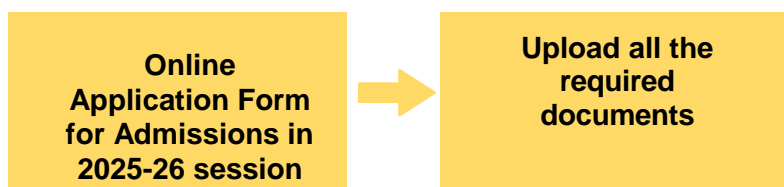
3. APPLICATION CATEGORIES

Foreign nationals are admitted to various [Programmes of Study](#) at the [University of Delhi](#) under the following categories:

- (a) **Self-financing Students:** including those who hold other schemes of scholarships.
- (b) **ICCR Students:** with the Indian Council for Cultural Relations (ICCR), Government of India (GoI) scholarships. **Such application reaches us through the ICCR only.**
- (c) **Casual Affiliation:** There is a provision of Casual affiliation in any course run by the University. It is permissible to a maximum of 2 semesters and it may not lead to the award of any degree.

4. ADMISSION PROCESS

- a) **All students** applying to the various programmes at University of Delhi need to first register at Study in India portal (<https://studyinindia.gov.in/how-to-apply-to-study-in-india?activeTabIndex=0>)
- b) **Applicants with scholarship other than ICCR, need to apply online at the FSR portal** <http://fsr.du.ac.in/index.html>



- c) ICCR applicants can also apply under self-paying students' category at the FSR portal (<https://fsr.du.ac.in/>)
- d) Casual Affiliation: Applicants may refer to Point No. 16. Important Information:

Personal Details:

Please ensure that students name entered in the application matches exactly with the name on the passport.

Academic Details:

Provide details of all the examinations upto the qualifying one and other exams as mentioned. Indicate your level of proficiency in English language.

Programme Of Study:

➤ **Select the programme of study** from the following options:

1. Under-Graduate (UG)
2. Post-Graduate (PG)
3. Certificate, Diploma and Advanced Diploma
4. Ph.D.
5. School of Open Learning (SOL) Programmes (UG and PG) *

*Only for Nepal, Tibet, Bhutan and **recognized** Refugees staying in Delhi.

Those working at diplomatic missions must submit their applications alongwith the recommendations of the Embassy/ High Commission

The candidate must ensure the fulfilment of the minimum eligibility criteria for the programme and the Courses which he/she is applying for.

Application and the NOC from Diplomatic Missions-

The old practice of submission of “No Objection Certificate” from the diplomatic mission would be required which can be uploaded on the portal. However, the original NOC will be required at the time of admission. The NOC Certificate may also be submitted after the provisional admission is prepared

PAYMENT

- Once the application is complete in all respects and has been previewed satisfactorily, the next step is the payment, click the “Submit” button to be directed to the payment gateway. The fee is to be paid online (Credit/ Debit/ Net-banking). The foreign currency Travel Card and Diners Club Card do not work. Once the fee is paid then only your application becomes valid. This application fee is completely Non-refundable.
- On the successful payment of fees, save a printout of the page.

***Medical insurance, and the NOC from the concerned Diplomatic Mission are required only at the time of admission, and they are not mandatory at the time of application.*

7. SELECTION PROCESS

Foreign nationals seeking admission in any course Certificate/ Diploma/Under-Graduate/ Post-Graduate/ Ph.D. are exempted from entrance test. The FSR admissions are given on merit basis. Therefore, the admissions are not related to the CUET eligibility. The applicant holding non-Indian Passport has to adhere to the FSR laid rules and regulations only. The requirement of subjects (such as Mathematics for specified UG courses) shall be followed strictly.

However for some admissions there is pre requirements along with option to undertake the test like:

- (a) For M.A. Economics, GRE score is mandatory with two Recommendation letters
- (b) For MBA-BE/MBA-FM/MBA-IB/MBA-HRD/Ph.D. Management ; A GMAT score (minimum 650) is mandatory.
- (c) For B.Tech & LL.B, there is desirability of IELTS/TOEFL. The selection in B tech courses will be based on the marks in the best 3 subjects. It is also applicable in all science courses

Applicants other than ICCR scholars may require English Proficiency Certificate/IELTS/TOEFL.

SOLICITING ANY MEETING DURING THE PROCESS OF ADMISSION PROCESS IN ANY DEPARTMENT FOR PH.D. IS PROHIBITED.

Admission in any Course shall not be granted on predicted scores.

All foreign nationals with foreign qualifications are required to submit the Equivalence certificate obtained from the [Association of the Indian Universities \(AIU\)](http://www.aiu.ac.in). Website: <http://www.aiu.ac.in>

8. Eligibility for MBA (Full-Time) in Faculty of Management Studies

- a. Foreign nationals seeking admission to the MBA (FT) program in FMS, Delhi University should have already passed in their qualifying degree program and must submit their qualifying degree final results with the application. Students pursuing their qualifying degree or waiting for results are not eligible to apply.
- b. Candidates must have a minimum score of 650 in GMAT (Focus Edition) or 320 in GRE as eligibility to apply for the admissions to the MBA (FT) program at FMS. The GMAT Score will be considered only if the exam is taken between July, 2024 and April 27th, 2025. THIS WOULD BE FOLLOWED STRICTLY
- c. Students who are recipients / awardees of study scholarships from either Govt of India or Government of the applicant's country are exempt from GMAT or GRE eligibility. However, the candidate must submit a certificate that the medium of instruction for their qualifying degree is English from his/ her institution.
- d. Out of the total 25 number of seats for foreign nationals, 8 are for SAARC region and 14 for other countries. There will be no transfer of seats from one category region to other regions.
- e. Selection of applicants will be based on the online interaction and evaluation

9. PROVISIONAL ADMISSION

Only those applicants who fulfill the eligibility requirements and are recommended for admission by the respective admission committee are issued a provisional admission letter by the Foreign Students' Registry (FSR) office. Applicants are advised to write their **email addresses** and other details **clearly** on the application forms.

Provisional admission letter does not guarantee a seat in any specific college of the University of Delhi.

All foreign students should report to the Foreign Students' Registry (FSR) office of University of Delhi by the date mentioned on the provisional admission letter.

10. APPLYING FOR A VISA

The Provisional Admission letter can be used for seeking for the Student/ Research visa in the applicant's home country/country of residence. The visa must be preferably endorsed in the name of the University of Delhi. For more information on visa requirements, please visit <https://indianvisaonline.gov.in/visa/index.html>

Student Visa (S-1): Student Visa is required for the enrolment in Undergraduate, Post-Graduate, Certificate, Diploma and Advanced Diploma courses must have of S-1 category only.

Research Visa (S-5): For Ph.D. students it is essential to hold S-5 Research Visa. **No admission shall be entertained on Tourist/ Medical/ Short Term visa.**

No Admission will be granted on Tourist Visa/ X-Visa.

11. ARRIVAL

Students should have adequate financial resources to cover their living expenses in Delhi. For those who would be receiving scholarships from ICCR or other sources should also ensure that they must have sufficient funds to cover their entire expenses. It may take a few months before the scholarship amount is released

12. ADMISSION FORMALITIES

The candidate undergoes the following formalities at FSR office:

- + Candidate has to complete the arrival form at FSR office.
- + Verification of valid Visa, Visa endorsement, Passport, Original Education Documents, Medical Insurance, English Proficiency Certificate/Academic scores, is done by FSR staff.
- + Candidate will be issued admission letter and is further advised to contact the Nodal Officer of allotted College/Department/Centre

13. CANCELLATION OF ADMISSION

The refund of fees is possible till specific dates . The same shall be announced on the FSR websites

14. TRANSFER AND CHANGE OF PROGRAMME

As per the rules of University of Delhi, no request for any Change of Programme and / or College will be entertained after the completion of the admission process.

⑩ Students, who desire to study for a short duration (maximum two semesters) in any Under-Graduate or Post-Graduate or Research Programme not leading to an Award/Certificate/Degree at University of Delhi, may apply for casual affiliation.

⑩ Students applying for casual affiliation should be currently enrolled for a Course of study at the University level in their home country. They may apply directly on the FSR website

⑩ **A letter of recommendation from the Director/ Head of the University** (where the student is currently enrolled) should be attached with the application.

Students desirous of such admission are also required to complete the Online Application Form.

18. SCHOOL OF OPEN LEARNING (S.O.L.)

Foreign Nationals from Nepal/ Tibet/ Bhutan/ Diplomats and **dependents living in Delhi** or holding PIO/ OCI card and residing in Delhi /NCR or who are currently working in Delhi can apply for School of Open Learning (S.O.L).

- a. Successful completion of an undergraduate physiotherapy degree (B.Sc. (PT) / BPT) from a recognized college/institute/university within India of not less than 4½ years duration (including 6 months of internship) with 55% of aggregate marks (50% for SC/ST/OBC-NC/Orthopedically disabled) in their university exams. Candidates who have completed 3 ½ years course and an additional bridge course of one (1) year will be considered equivalent to 4 ½ years course.
- b. An undergraduate physiotherapy qualification (B.Sc. (PT) / BPT etc.) of 3 ½ years duration from a recognized college/ institute/ university plus at least ten (10) years of work experience.
